# Importing Already-Existing Media Content into Panopto

Panopto has many powerful features when it comes to sharing and uploading videos. Because of this, you may wish to upload content that was created **before** Panopto launched. For legal purposes, you will need to ensure that your video meets the below criteria, before uploading onto Panopto.

# 1) First, identify which category your already-existing content falls into



# Approved for upload

Videos that are Copyrightcleared, and **do not** contain or visually/verbally mention a past or current student, can be uploaded to Panopto without reading any further.



## Check waivers before uploading

For any video that was created between September 1<sup>st</sup>, 2014 and December 21<sup>st</sup>, 2018, **and** includes, or visually/verbally mentions a past or current student, see the instructions below.



### Seek talent permission first

For any video created before September 1<sup>st</sup>, 2014 that includes, or visually/verbally mentions a past or current student, you need to seek written permission from those appearing in the video, before uploading it onto Panopto.

## 2) If your content falls into the "check waivers before uploading" category, see below:

Before uploading, you will need to ensure that you have the correct, Panopto-approved waiver(s) on file.

- Check the list of reference waivers included in this document to see if it matches with the one(s)
  used in your video. Only the wording needs to match; it is acceptable if your version has a
  different visual layout.
- 2. If your waiver *matches* one of the waivers listed in this document, then you are good to upload the video onto Panopto.
- 3. If you do not have a waiver, then you cannot use or upload the video onto Panopto.
- 4. If your waiver **does not** match one of the reference waivers listed in this document, please connect with <a href="mailto:panopto@humber.ca">panopto@humber.ca</a> for advice. We will review the waiver that has been used, and determine if the content passes legal requirements.
